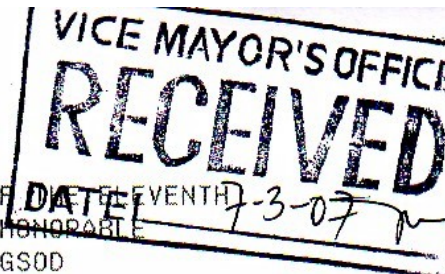

Government;



Heads, and all others concerned in Ormoc City;


