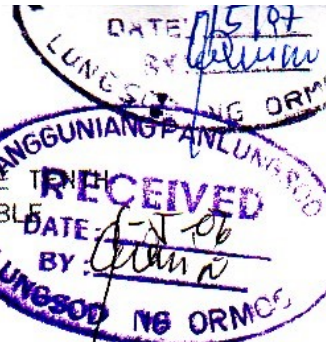

RESOLUTION NO. 2007-006

A RESOLUTION RETURNING TO COL. DIONISIO B. TORREVILLAS, REGIONAL COMMANDER, ORMOC CITY VETERANS FEDERATION, THEIR PROPOSAL FOR THE CONSTRUCTION OF A VETERANS MEMORIAL WALL AT THE VETERANS PARK THIS CITY, WITH THE ADVISE THAT THE ROSTER BE PLACED AT THE BACK OF THE EXISTING VETERANS MEMORIAL AND THAT THE PLAN AND DESIGN BE SUBMITTED TO THE CITY PLANNING AND DEVELOPMENT OFFICE.

WHEREAS, this Sanggunian is in receipt of the 1st Indorsement dated 21 November 2006 re: letter from Col. Dionisio B. Torrevillas, Regional Commander, Veterans Federation, this city regarding the proposed construction of a Veterans Memorial Wall at the Veterans Park this City.

WHEREAS, said request was indorsed to the City Planning and Development Coordinator for comments of the following concerns:

- a) Whether such construction would not obstruct the aesthetic view of the city plaza;
- b) Whether it is in accordance with the motif of the city plaza; and
- c) Whether the listing of names would be better if placed at the existing Veterans Memorial.

WHEREAS, the City Planning and Development Coordinator through 3rd Indorsement dated 22 December 2006 has recommended the utilization of the back portion of the existing structure at the Veterans Park for the purpose of listing down the names of Veterans and or Members of the Western Leyte Guerilla Warfare Forces;

WHEREFORE, FOREGOING PREMISES considered, on motion of the City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Public Properties, duly seconded by City Councilor Sotero M. Pepito; be it


