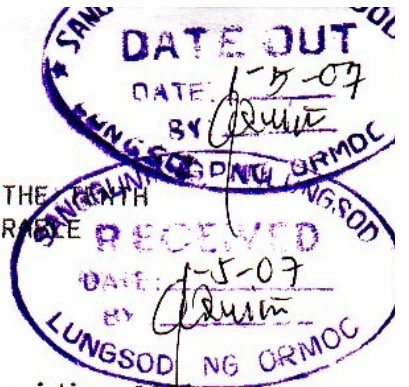

RESOLUTION NO. 2007-007

A RESOLUTION COMMENDING A CERTAIN GUERLEO GUCELA A ROOM BOY OF SKY GARDEN AND AN ORDINARY CITIZEN, WHO AT THE RISK OF HIS LIFE AND LIMBS WENT OUT HIS WAY TO ASSIST MITZIENELLE C. GONZALEZ ESCAPE DURING THE CONFLAGRATION WHICH TOOK THE LIVES OF 26 PEOPLE.

WHEREAS, on the afternoon of December 25, 2006, Christmas Day, at about 4:00 o'clock in the afternoon fire broke at the Uni Top Department Store, burning it to the ground the whole structure and taking with it the lives of 26 people;

WHEREAS, one of those who escaped the raging blaze was a young female nursing student in the course of her escape was helped by one Guerleo Gucela, who at the risk of his life and limbs come to the aid of a complete stranger;

WHEREAS, the Sangguniang Panlungsod ng Ormoc believes that this good deed should not be hidden but should however be made public for others to emulate;

WHEREFORE, foregoing premises considered on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution COMMENDING A CERTAIN GUERLEO GUCELA A ROOM BOY OF SKY GARDEN AND AN ORDINARY CITIZEN WHO AT THE RISK OF HIS LIFE AND LIMBS WENT OUT HIS WAY TO ASSIST MITZIENELLE C. GONZALEZ ESCAPE DURING THE CONFLAGRATION WHICH TOOK THE LIVES OF 26 PEOPLE;

RESOLVED, FURTHER, to give cash incentive to Guerleo Gucela in the amount of Five Thousand Pesos (P5,000.00);


