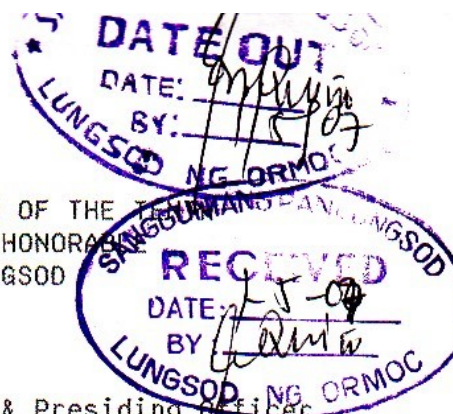

RESOLUTION NO. 2007-008

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO RELEASE FOR TITLING/OWNERSHIP OF THE HOME LOTS AT THE JICA RESETTLEMENT SITE AT BARANGAY LAO, THIS CITY TO THE 206 ORIGINAL AND QUALIFIED ALLOCATEES AS DETERMINED AND VERIFIED IN THE OFFICE RECORD OF THE CSWDO AND RECOMMENDED BY THE CSWDO OFFICER, MRS. MARIETA LEGASPI, SUBJECT TO THE TERMS AND CONDITIONS, HEREIN STATED.

WHEREAS, the City Government of Ormoc agrees to release the ownership/title of the home lots to Original qualified occupants at the resettlement site for those affected by the JICA Flood Control and mitigating project;

WHEREAS, Brgy. Lao, in a Barangay Resolution No. 37 s. 2006 requested City Mayor Eric C. Codilla through the Sangguniang Panlungsod ng Ormoc to release the home lots of those residents of Purok VI where the relocation area of those affected by the JICA Flood Mitigation is located;

WHEREAS, attached hereto is a copy of the Statement of Understanding signed by the Original allocatees;

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Public Properties, jointly seconded by City Councilors Sotero M. Pepito and Claudio P. Larrazabal; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO RELEASE FOR TITLING/OWNERSHIP OF THE HUMILITIES AT THE JICA RESETTLEMENT SITE AT BARANGAY LAO, THIS CITY TO THE 206 ORIGINAL AND QUALIFIED ALLOCATEES AS DETERMINED AND VERIFIED IN THE OFFICE RECORD OF THE CSWDO AND RECOMMENDED BY THE CSWDO OFFICER, MRS. MARIETA LEGASPI, SUBJECT TO THE TERMS AND CONDITIONS, HEREIN STATED;


1. That ownership of the homelots will be released to qualified occupants sans cost to them;
2. That the cost of the individual titling of the homelots will be borne solely by the beneficiaries thereof;
3. That ^Qthose homelots shall not be transferred or assigned to any person, natural or juridical, within a period of twenty five (25) years from the date of the individual titling thereof, except by hereditary succession, and any transfer or assignment in violations hereof shall be null and void;
4. That the lawful owner may mortgage the homelots to any government financial and/or government home-financing institutions, to secure a loan for the construction/repair/remodeling of the house in said lot, in which case the said owner shall notify in writing the City Government of Ormoc;
5. That conditions three (3) and four (4) hereof, shall be incorporated in the document of transfer from the City Government of Ormoc to the qualified occupants/beneficiaries, and further annotated in the Certificates of title that may be issued to the qualified occupants/beneficiaries.


