A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, ERIC C. CODILLA TO SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF EDUCATION (DepEd) ON THE OPENING OF NIGHT CLASSES IN THE NEW ORMOC CITY NATIONAL HIGH SCHOOL (NOCHS) THIS SY 2007-2008.

WHEREAS, the latest census conducted by the Ormoc City Schools Division showed that there are around 12,432 disadvantaged youth in Ormoc city within the age range of 12-24 who are deprived of access to formal education both in the elementary and secondary levels due to the fact that they need to work during the day to survive and augment family income;

WHEREAS, Section 1, Article XIV of the 1987 Philippine Constitution provides that, "the state shall protect and provide the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all"; (underscoring supplied)

WHEREAS, the DepEd has taken the initiative to offer special night classes in the NOCHS, SY 2007-08 specifically designed for this marginalized group of out-of-school youths (OSYs);

WHEREAS, necessary preparations had been made by the City Schools Division to ensure that all the conditions set forth in Section 6, Chapter 2 of the DECS Service Manual on the operations of nights classes are met;

WHEREAS, the favorable indorsement of the Local School Board (LSB) to approve the opening of night classes in NOCHS this year implies/dictates that the project be given the fullest support;

NOW, THEREFORE, on motion of City Councilor Filomeno P. Maglasang, Chairman, Committee on Education, severally seconded by City Councilors Fernando P. Parrilla, Mariano Y. Corro, Ruben R. Capahi and Sotero M. Pepito; be it
