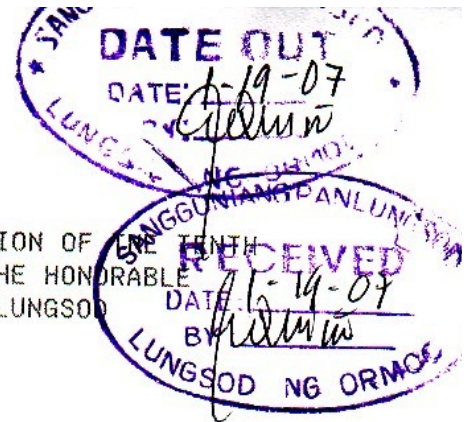

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE CONSULTANCY CONTRACT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH MR. MANUEL M. PASCUAL AS FINANCIAL CONSULTANT FOR THE CITY GOVERNMENT OF ORMOC UNTIL JUNE 30, 2007.

WHEREAS, this Sanggunian is in receipt of letter dated January 03, 2007 from the Office of the City Mayor requesting for the approval of this Sanggunian for him to sign/enter into contract re: Contract of Service between the City Government of Ormoc and Mr. Manuel M. Pascual as Financial Consultant of his office for one (1) calendar year;

WHEREAS, it can be recalled that this Sanggunian passed S.P. resolution No. 2006-096 entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE CONSULTANCY CONTRACT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH MR. MANUEL M. PASCUAL AS FINANCIAL CONSULTANT FOR THE CITY GOVERNMENT OF ORMOC", with ₱1.00 honorarium;




