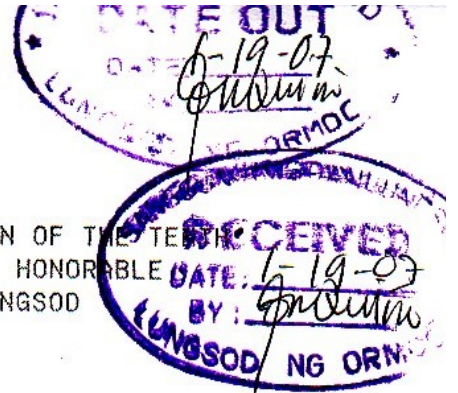

RESOLUTION NO. 2007-012

A RESOLUTION FAVORABLY INDORSING TO THE NATIONAL HISTORICAL INSTITUTE THE REQUEST FOR RECONSIDERATION OF THE SANGGUNIANG BARANGAY OF BARANGAY KADAOHAN FOR THE RENAMING OF SAID BARANGAY TO BARANGAY BONIFACIO G. NAVARRO, THIS CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated 02 January 2007 from Hon. Deonesio G. Aligway, Punong Brgy. of Barangay Kadaohan, this city requesting this august Body for help in their desire to ask for a reconsideration to the National Historical Institute, renaming Barangay Kadaohan to Barangay Bonifacio G. Navarro;

WHEREAS, Section 13 Par. (b) of Republic Act 7160 otherwise known as the Local Government Code of 1991, in part provide that;

"(b) The Sanggunians of highly urbanized cities and of component cities whose charters prohibit their voters from voting for provincial elective officials, hereinafter referred to in this Code as independent component cities may, in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction:

- (1) City barangays, upon the recommendation of the sangguniang barangay concerned;

WHEREAS, it can be recalled that this august Body passed S.P. Resolution No. 97-54 dated April 3, 1997 entitled: "A RESOLUTION SEEKING FROM THE NATIONAL HISTORICAL COMMISSION AND ADVISE ON THE PROPRIETY OF CHANGING THE NAME OF BARANGAY KADAOHAN, THIS CITY, TO BARANGAY BONIFACIO NAVARRO AS REQUESTED BY THE BARANGAY OFFICIALS OF BARANGAY KADAOHAN AS EMBODIED IN THEIR RESOLUTION NO. 22 SERIES OF 1997, COPY OF WHICH IS HERETO ATTACHED FOR READY REFERENCE";

WHEREFORE, foregoing premises considered on MASS MOTION of the Body; be it


