WHEREAS, the People's Law Enforcement Board of Ormoc City was created  
through SP Resolution No. 39 dated 13 August 1992 in pursuance to Republic  
Act 6975 particularly Section 43 par. (a) thereof;

WHEREAS, under said law, the People's Law Enforcement Board (PLEB), is  
tasked to hear and decide citizen's complaints or cases filed before it  
against erring officers and members of the PNP within the jurisdiction of  
Ormoc City;

WHEREAS, Section 43, par. 13 of the aforecited RA 6975, provides for  
the composition of the PLEB as follows:

1. Any member of the Sangguniang Panglungsod/ Bayan chosen by his  
respective sanggunian;
