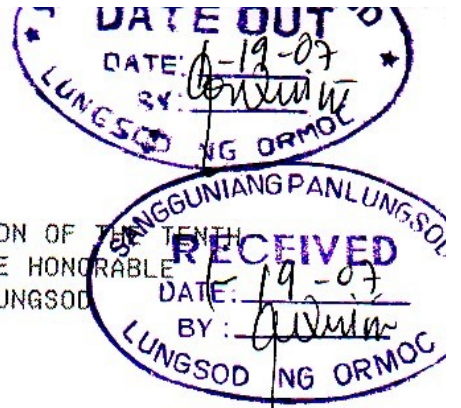

EFFECTIVE JANUARY 8, 2007.

PRESENTED, for concurrence by this august Body through 1st
Indorsement dated 8 January 2007 from the Honorable City Mayor Eric C.
Codilla, is the appointment of Engr. Domardoni C. Cayanong as City
Government Department Head I (City General Services Officer) this city,
effective January 8, 2007;

WHEREAS, Art. 119, Par. (a) - Rules and Regulations Implementing
the Local Government Code provides:

"(a) Unless otherwise provided in this Rule, heads of offices and
departments in the LGU's shall be appointed by the local chief
executive concerned with the concurrence of a majority of all
the members of the sanggunian, subject to civil service laws,
rules and regulations." (underscoring supplied)

accordance with pertinent provisions of the Local Government Code;
