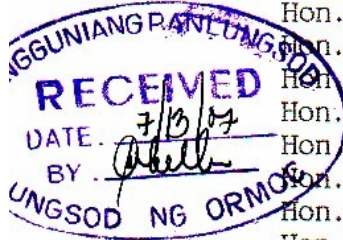
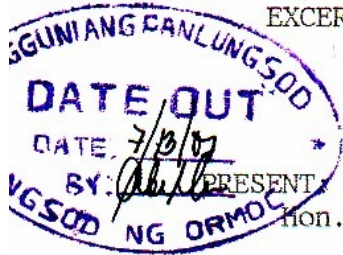

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), THE LOCAL GOVERNMENT OF ORMOC CITY (LGU), AND THE DEUTSCHE GESELLSCHAFT FOR TECHNISCHE ZUSAMMENARBEIT (GTZ).

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated July 03, 2007 from the Office of the City Mayor requesting for authority to sign the Memorandum of Agreement between the Department of Environment & Natural Resources, the Ormoc City LGU and the Deutsche Gesellschaft for Technische Zusammenarbeit;

WHEREAS, the aforementioned MOA refers to the unification of the above parties along with the concept in eco-governance joining their hands together to pledge, commit and agree to develop and strengthen the organized People's Organization with registered name Naungan and San Juan Mangrove Planters Association (NSJMPA) with the local address at Brgy. Naungan, Ormoc City;

WHEREAS, the protection, maintenance and development of those areas mentioned is not only the concern of the DENR but it involves also the participation of the LGU concerned and People's Organization herein mentioned;
