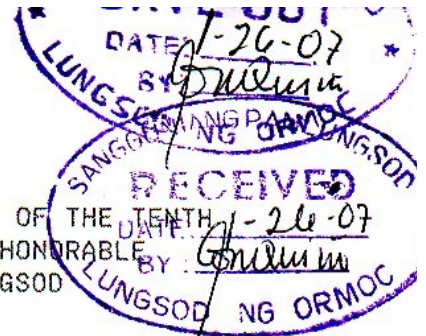

RESOLUTION NO. 2007-018

A RESOLUTION APPROVING ORDINANCE NO. 2006-03 OF THE BARANGAY COUNCIL OF LINAO, THIS CITY, ENTITLED: AN ORDINANCE IMPOSING GARBAGE FEE COLLECTION IN THE AMOUNT OF ONE PESO (P1.00) PER BAG COLLECTED FROM ALL HOUSEHOLD AND FROM ALL BUSINESS ESTABLISHMENT OPERATING WITHIN THE JURISDICTION OF BARANGAY LINAO, ORMOC CITY".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2006-03 from the Barangay Council of Barangay Linao, entitled: "AN ORDINANCE IMPOSING GARBAGE FEE COLLECTION IN THE AMOUNT OF ONE PESO (P1.00) PER BAG COLLECTED FROM ALL HOUSEHOLD AND FROM ALL BUSINESS ESTABLISHMENT OPERATING WITHIN THE JURISDICTION OF BARANGAY LINAO, ORMOC CITY;

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to Review as to whether the said ordinance is consistent with law and city x x x ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Linao to legislate;
