A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE DEED OF DONATION IN FAVOR OF THE CITY GOVERNMENT OF ORMOC AS DONEE AND THE PNOC - ENERGY DEVELOPMENT CORPORATION AS DONOR OF THREE (3) PIECES USED ROCK BITS TO IMPROVE THE WATER SYSTEM.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 10 July 2007 from the Honorable City Mayor requesting for authority to sign the Deed of Donation in favor of the City Government of Ormoc as Donee and the PNOC-Energy Development Corporation as Donor of three (3) pieces used rock bits to improve the Water System of this City;

WHEREAS, said Deed of Donation mentions of the act of the PNOC-Energy Development Corporation (PNOC-EDC) herein referred to as the Donor to voluntarily and freely convey, by way of donation unto the Donee, the City Government of Ormoc, all the rights, title, interest which the Donor has in the aforementioned used rock bits;




