MORALES CONSTRUCTION FOR THE INSTALLATION OF ELECTRICAL AND PERIMETER LIGHTING FIXTURES OF BARBECUE PARK CITY FOOD PARK) PER BAC RESOLUTION NO. 2007-177 DATED WIRINGS (ORMOC TULY 17, 2007 IN THE AMOUNT OF ONE HILLEN PESOS 2007 IN THE AMOUNT OF ONE MILLION THREE HUNDRED FORTY AND
