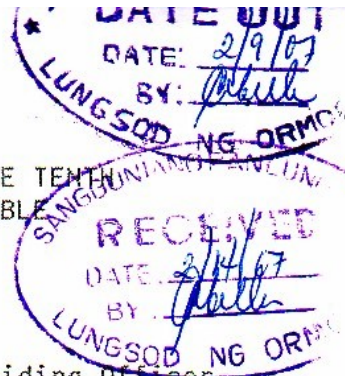

RESOLUTION NO. 2007-025

A RESOLUTION APPROVING ORDINANCE NO. 3 OF THE BARANGAY COUNCIL OF BARANGAY VALENCIA, THIS CITY, ENTITLED: "AN ORDINANCE IMPOSING A TAX ON STORES, OR RETAILERS, WITH FIXED BUSINESS ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOORS SIGNS, SIGNBOARDS, AND BILLBOARDS, AND FEES ON CLEARANCES AND CERTIFICATIONS ISSUED TO ANY PERSON, RENTAL OF THE BARANGAY FACILITIES AND PUBLIC MARKET."

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 3 of the Barangay Council of Barangay Valencia, this city, entitled: "AN ORDINANCE IMPOSING A TAX ON STORES, OR RETAILERS, WITH FIXED BUSINESS ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR SIGNS, SIGNBOARDS, AND BILLBOARDS, AND FEES ON CLEARANCES AND CERTIFICATIONS ISSUED TO ANY PERSON, RENTAL OF THE BARANGAY FACILITIES AND PUBLIC MARKET.

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the power to review as to whether said ordinance is consistent with law and city x x ordinances; (Sec. 57, 1991 LGC);

WHEREAS, it is the observation of this august Body the the said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Valencia to legislate;


