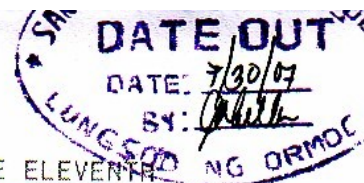

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST THE NON-OFFICE ITEM- PROVISION FOR PRIOR YEAR'S OBLIGATION-UNDER THE CITY'S ANNUAL BUDGET FOR CY 2007 THE AMOUNT OF THREE THOUSAND SIX HUNDRED FORTY FIVE PESOS & 15/100 (P3,645.15) FOR THE SALARY STEP INCREMENTS OF CSWDO PERSONNEL EFFECTIVE JULY AND AUGUST 2006 BROKEN DOWN AS FOLLOWS:

WHEREAS, the 11th Sangguniang Panlungsod ng Ormoc is in Receipt of a 3rd Indorsement dated July 16, 2007 from the Office of the City Mayor relative to the request of Mrs. Marietta S. Legaspi, CSWD Officer, this City, for a supplemental appropriation in the total amount of THREE THOUSAND SIX HUNDRED FORTY FIVE PESOS & 15/100 (P3,645.15) for the salary step increments of CSWDO personnel effective July and August 2006;

WHEREAS, in an indorsement dated July 16, 2007, the Human Resource and Management Officer, Mrs. Adelaida H. Biacolo, has stated that the salary step increments were inadvertently omitted in the Schedule of Salary Step Increments of Regular Employees, hence, there is a need for a supplemental appropriation to cover said deficiency;

WHEREAS, the City Budget Officer, in her 6th Indorsement dated July 23, 2007, has recommended to this august Body to grant the City Accountant an authority to charge said request against the Non-Office item-Provision for Prior Year's Obligation- under the city's Annual Budget for CY 2007;


