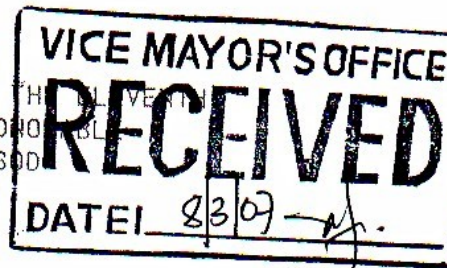
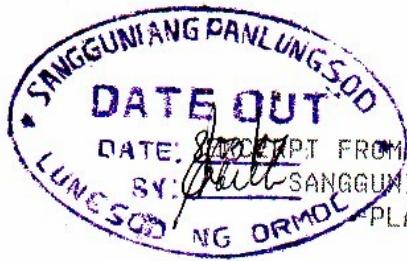
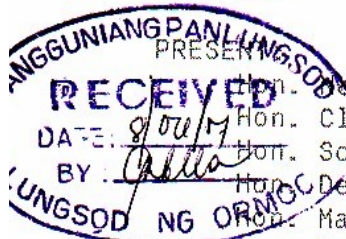

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE RENEWAL CONTRACT FOR CONSULTANCY OF DR. SAMUEL S. GO, AS CONSULTANT FOR AGRICULTURE, THIS CITY, EFFECTIVE FEBRUARY 1, 2007 TO DECEMBER 31, 2007.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated July 02, 2007 from the office of the City Mayor urgently requesting for the passage of a resolution granting the Honorable City Mayor Eric C. Codilla an authority to enter and sign the renewal contract of consultancy of Dr. Samuel S. Go, as Consultant for Agriculture, this City;

WHEREAS, it can be recalled that this august Body passed SP Resolution No. 2004-053 dated August 27, 2004, entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO A CONSULTANCY AGREEMENT WITH DR. SAMUEL S. GO AS CONSULTANT ON AGRICULTURE";
