A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF MRS. EMERITA GEMENTIZA FOR SURVEY AUTHORITY FOR THE SEGREGATION SURVEY OF A PARCEL OF LAND LOCATED AT BRGY. MONTERICO, ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated November 2006 from ENGR. CARLITO L. CASTAÑARES, Chief, Survey Party, CENRO, Albuera, Leyte, regarding the application of Mrs. Emerita Gementiza for the approval of survey authority for the Segregation Survey of a parcel land particularly described as Lot No. 10931 Part, under Tax Declaration No. 00061-00135 (R10) situated at Brgy. Monterico, this city;

WHEREAS, ENGR. ARTHUR C. ARCUINO, Tax Mapper IV, City Assessor's Office, thru 1st Indorsement dated November 30, 2006, has pointed out that the subject lot is free from any adverse claims and conflicts and is not subject to any future development plan considering the 6 kilometer distance from the barangay site;

WHEREAS, the City Engineer Wilfredo A. Fiel, in his 6th Indorsement dated 23 January 2007 has stated that the subject lot is not traversed by any proposed road;

WHEREAS, the Deputy Register of Deeds I, Mr. Placido Edgar E. Mata, of the Registry of Deeds, Ormoc City, has certified that Lot No. 10931-Part under Tax Declaration No. 00061-00135 R10 situated in Barangay Monterico, this city, is declared a Public Land under Bienvenido Gementiza as Administrator:
