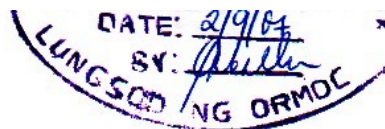

CODILLA TO ENTER INTO AND SIGN THE DEED OF DONATION FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH LEYTE GULF LAND CORPORATION FOR THE DONATION OF OVERHEAD TANK, SUBMERSIBLE PUMP, AND PIPELINES LOCATED AT BARANGAY SAN PABLO, THIS CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 06 February 2007 from the Honorable City Mayor Eric C. Codilla, requesting for authority to sign the Deed of Donation with Leyte Gulf Land Corporation for the donation of overhead tank, submersible pump, and pipelines located at Barangay San Pablo, this city, in favor of the City Government of Ormoc;

WHEREAS, the said network of pipelines and implements could be of great help to the City Government of Ormoc in its on going rehabilitation of the water system which is a priority project of the city;
