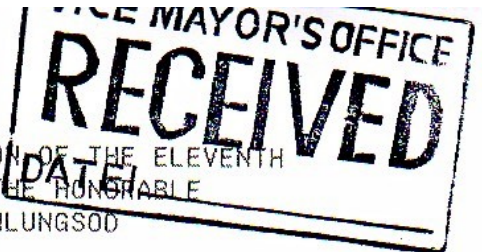

RESOLUTION NO. 2007-031

A RESOLUTION RESPECTFULLY REQUESTING HON. PAUL AQUINO, PRESIDENT OF PNOC-EDC TO FURNISH THE SANGGUNIANG PANLUNGSOD NG ORMOC, THE BASIS AND COMPUTATION OF THE ROYALTY FEES RECEIVED BY THE CITY GOVERNMENT OF ORMOC FROM PNOC-EDC FOR ITS DEVELOPMENT AND OPERATION OF GEOTHERMAL PLANTS WITHIN THE TERRITORIAL JURISDICTION OF ORMOC CITY.

WHEREAS, the City Government of Ormoc has been receiving the royalty fees from PNOC-EDC for its development and operation of geothermal plants within the territorial jurisdiction of Ormoc City from the third quarter of 1997 to the present;

WHEREAS, the Royalty fees received in the form of checks are without any computation nor the basis thereon shown, hence the City Government of Ormoc is at loss of how the Royalty Fees received were arrived at;

WHEREAS, for the better appreciation and understanding of the City Government of Ormoc on the Royalty Fees it has been receiving from PNOC, it would be to our benefit and advantage that the basis and computation of our Royalty Fee be shown or be known;




