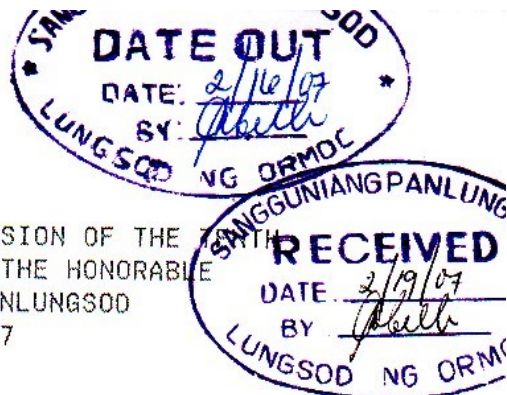

RESOLUTION NO. 2007-032

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, FOR THE IMPLEMENTATION OF THE SPECIAL LOCAL ROAD FUND (SLRF) UNDER R.A. 8794 OR THE MOTOR VEHICLE USERS CHARGE (MVUC) LAW.

WHEREAS, this Sanggunian is in receipt of 2nd indorsement dated January 29, 2007 from the office of the City Mayor Eric C. Codilla, to enter into and sign the Memorandum of Agreement (MOA) with the Department of Public Works and Highways for and in behalf of the City Government of Ormoc for the implementation of the Special Local Road Fund (SLRF) under R.A. 8794 or the Motor Vehicle Users Charge (MVUC) Law;

WHEREAS, this agreement covers the release, utilization and liquidation of funds for the LGU eligible projects and activities such as road maintenance, road safety devices and traffic management funded by the Special Local Road Fund to be implemented by LGUs in accordance with the policies, standards and procedures of R.A. 8794 (MVUC Law) and its implementing Rules & Regulations;

WHEREAS, this august Body believes that said request is reasonable hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructure, jointly seconded by City Councilors Sotero M. Pepito and Mariano Y. Corro; be it
