RESOLUTION NO. 2007-032

A RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT MANAGER, GEOTHERMAL GENERATION, NATIONAL POWER CORP., ORMOC CITY, FOR A CERTIFIED DATA OF NAPOCOR'S PURCHASES OF ELECTRICITY FROM 1996 TO PRESENT FROM PNOC-EDC GEOTHERMAL PLANTS LOCATED WITHIN THE TERRITORIAL JURISDICTION OF ORMOC CITY.

WHEREAS, the City Government of Ormoc has been receiving Royalty Fees from PNOC-EDC for its development and operations of geothermal plants within the territorial jurisdiction of Ormoc City in compliance with the mandate of the Local Government Code of 1991;

WHEREAS, the Royalty Fees received by the City Government of Ormoc since 1997 up to the present do not show the basis and computation thereof;

WHEREAS, according to Section 291 of the LGC for the utilization and development of the national wealth, the local government where such wealth is located is entitled to one percent (1%) of the gross sales or receipts of the preceding calendar year;

WHEREAS, for the proper guidance of the City Government of Ormoc of its Royalty fees from PNOC-EDC, it is necessary to know the amount which NAPOCOR paid to PNOC-EDC for the electricity it purchases from the latter which were generated from its geothermal plants located within the territorial jurisdiction of Ormoc, hence this request;

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Energy, jointly seconded by City Councilors Demosthenes F. Tugonon and Sotero M. Pepito; be it


