A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT (MOA) WITH THE DRMOC MATERNITY AND CHILDREN'S HOSPITAL REPRESENTED BY ITS PRESIDENT, MRS. ESTRELLA P. ABLEN.

WHEREAS, this Sanggunian is in receipt of a 1st Indorsement dated 19 January 2007 from the Office of the City Mayor relative to the letter of Mrs. Estrella P. Ablen, President, Ormoc Maternity and Children's Hespital, Inc., this city, in connection with their plans of upgrading the facilities of the said hospital which will include the construction of a new hospital extension that will accommodate both the laboratory and additional private rooms of the hospital;

WHEREAS, in consideration of such useful undertaking, a new Memorandum of Agreement by and between the City Government of Ormoc and Ormoc Maternity and Children's Hospital has been executed and eventually supercede and render the previous Memorandum of Agreement dated December 2, 1997 as null and void;

WHEREAS, the new Memorandum of Agreement provides that Ormoc Maternity & Children's Hospital will further use the lot as LESSEE for and in consideration of a token/or minimal rental in the sum of TWELVE THOUSAND PESOS (P12,000.00) a year starting January, 2007 and for a period of TWENTY FIVE (25) YEARS renewable upon the mutual agreement of the parties;

WHEREAS, this august Body finds all the provisions of the new Memorandum of Agreement as just and reasonable, hence, must be given due course of action;
