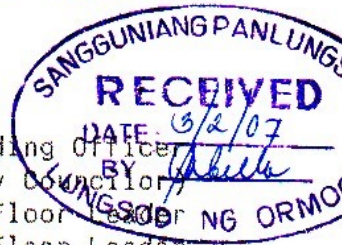

ADOPTED, March 01, 2007.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
