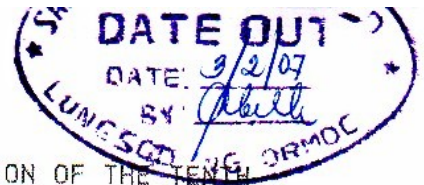

PANGANDAMAN, AL HAJ, RELATIVE TO THE REHABILITATION/REPAIR OF THE FARM - TO - MARKET ROAD OF SITIO VISORIA, BRGY. MANLILILINAO, THIS CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated February 09, 2007 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Hon. City Mayor Eric C. Codilla to sign the Memorandum of Agreement (MOA) with the Department of Agrarian Reform (DAR) represented by the Honorable Secretary Datu Nasser C. 
ADOPTED, March 01, 2007.
