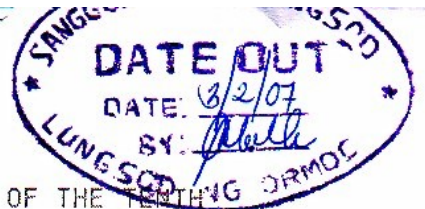

RESOLUTION NO. 2007-042

A RESOLUTION INFORMING THE REGISTER OF DEEDS OF ORMOC CITY REGARDING THE STAND OF THE 10TH SANGGUNIANG PANLUNGSOD THAT IT IS NOT ANYMORE NECESSARY FOR THE CITY MAYOR TO EXECUTE A DEED OF DONATION TO QUALIFIED ALLOCATEES OF THE LGU RELOCATION SITES SINCE A RESOLUTION AUTHORIZING THE RELEASE OF THOSE LOTS HAVE ALREADY BEEN PASSED.

WHEREAS, this Sanggunian passed several resolutions authorizing the Honorable City Mayor to release for titling resettlement sites to qualified allocatees as determined and verified by the proper offices concerned;

WHEREAS, lately, however, the qualified allocatees of Barangay San Isidro and Lao resettlement sites have been informed by the Register of Deeds, this city, that proper representation will be made to request the Honorable City Mayor to execute a Deed of Donation involving said lots in favor of the qualified allocatees;

WHEREAS, precedents and records will show that several lots were released for titling and that no Deed of Donation were executed by the Honorable City Mayor;

WHEREAS, it is for the this reason that this august Body believes that there is no longer a need to execute a Deed of Donation;

WHEREFORE, foregoing premises considered, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution INFORMING THE REGISTER OF DEEDS OF ORMOC CITY REGARDING THE STAND OF THE 10TH SANGGUNIAN PANLUNGSOD THAT IT IS NOT ANYMORE NECESSARY FOR THE CITY MAYOR TO EXECUTE A DEED OF DONATION TO QUALIFIED ALLOCATEES OF THE LGU RELOCATION SITES SINCE A RESOLUTION AUTHORIZING THE RELEASE OF THOSE LOTS HAVE ALREADY BEEN PASSED;
