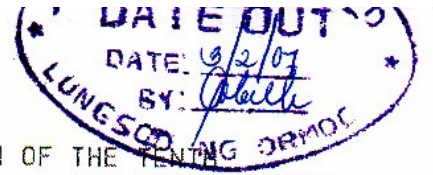

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH HONORABLE EUFROCINO M. CODILLA, SR., REPRESENTATIVE, FOURTH DISTRICT OF LEYTE, FOR THE ALLOCATION OF TEN MILLION PESOS (P10,000,000.00) OUT OF THE CONGRESSIONAL FUNDS AS FINANCIAL ASSISTANCE TO THE CITY OF ORMOC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated February 15, 2007 from the Honorable City Mayor Eric C. Codilla requesting for authority to sign the Memorandum of Agreement (MOA) for and in behalf of the City Government of Ormoc, with Honorable Eufrocino M. Codilla, Sr., Representative, 4th District of Leyte;

WHEREAS, the said Memorandum of Agreement (MOA) pertains to the allocation of TEN MILLION PESOS (P10,000,000.00) from out of the Congressional funds as financial assistance to the city for the promotion of health and to be utilized specifically as aid to Ormoc District Hospital, this city;

WHEREAS, this august Body believes that said financial assistance is of great help to the City of Ormoc, hence, the same should be accorded the necessary course of action;

WHEREFORE, foregoing premises, considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Health, severally seconded by City Councilors Claudio P. Larrazabal, Mariano Y. Corro and Eduardo P. Tan; be it
