WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated August 03, 2007 from the Office of the City Mayor for the approval of this Sanggunian for him to enter and sign into contract re: Renewal of Contract of Service between the City Government of Ormoc and Mr. Manuel M. Pascual as Financial Consultant of his office;

WHEREAS, it can be recalled that this august Body passed SP Resolution No. 2006-096 entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE CONSULTANCY CONTRACT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH MR. MANUEL M. 
