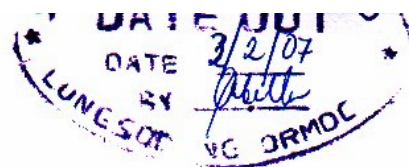

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C.
CODILLA TO SIGN AND ACCEPT THE DEED OF DONATION
EXECUTED BY THE PNOG ENERGY DEVELOPMENT CORPORATION
IN FAVOR OF THE DEPARTMENT OF EDUCATION AND THE CITY OF
ORMOC.

WHEREAS, this Sanggunian is in receipt of a 1st Indorsement dated
February 28, 2007 from the Honorable City Mayor requesting for authority
to sign and accept the Deed of Donation executed by the PNOG Energy
Development Corporation in favor of the Department of Education and the
City of Ormoc;

WHEREAS, the aforementioned Deed of Donation relates that the PNOG
Energy Development Corporation herein referred to as the DONOR freely
and voluntarily gives, transfers, and conveys by way of donation to the
Department of Education and the City of Ormoc as DONEE the different
school facilities and equipments which have been constructed completely
at Tongonan Elementary School in Brgy. Tongonan, Ormoc City, through the
supervision and financial support from the DONOR as contained in the
previous Memorandum of Agreement (MOA) which have been entered into and
by same parties on May 27, 2005;

WHEREAS, this august Body ^{believes} that said request is reasonable, hence,
the same must be accorded due course of action;
