A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE DEED OF DONATION EXECUTED BY THE VISAYAS GEOTHERMAL POWER COMPANY AND CE LUZON POWER COMPANY, INC., AS DONORS IN FAVOR OF THE DEPARTMENT OF EDUCATION, ORMOC CITY DIVISION, DOLORES ELEMENTARY SCHOOL, THE 4TH CONGRESSIONAL DISTRICT OF LEYTE AND THE LOCAL GOVERNMENT OF ORMOC CITY AS DONEES FOR A TWO-ROOM CONCRETE BUILDING CONSTRUCTED AT THE PREMISES OF DOLORES ELEMENTARY SCHOOL, BARANGAY DOLORES, THIS CITY AT THE COST OF P813,242.26.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated August 01, 2007 from the office of the City Mayor urgently requesting for authority to sign the deed of donation executed by the Visayas Geothermal Power Company, CE Luzon Geothermal Power Company, Inc., as DONORS in favor of the City Government of Ormoc, the Department of Education, Ormoc City Division, Dolores Elementary School and the 4th Congressional District as DONEES, of two-room concrete building constructed within the premises of Dolores Elementary School, Brgy. Dolores, this city at the cost of EIGHT HUNDRED THIRTEEN THOUSAND TWO HUNDRED FORTY TWO PESOS & 26/100 (P813,242.26);

WHEREAS, as cited in said Deed of Donation, the DONORS support the upliftment of the quality education of the youth of Leyte;

WHEREAS, as a gesture of gratitude for the Kindness, liberality and generosity of the DONORS, the DONEES accept the said donation and undertake to provide supervision, management, security, maintenance and preservation of the donation from construction and thereafter;

WHEREAS, this august Body believes that the said request is reasonable, hence, the same be accorded due course of action;
