- A. Assess or evaluate applications of the following nature;
  - 1. Variances
  - 2. Exceptions
  - 3. Non-Conforming uses
  - 4. Complains & Opposition to Application/s

- B. Assess or review appeals on grant or denial of Locational Clearance or Zoning Certificate by the Administrator.
- C. Prepare recommendation to the Sangguniang Panlungsod for its approval or disapproval.

WHEREAS, the subject City Development Council Resolution also provides that the Local Zoning Board of Adjustment and Appeals (LZBAA) shall act and make their recommendation to the Sangguniang Panlungsod within fifteen (15) days from receipt of the applications or public hearing as the case maybe;
