A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ACCEPT AND SIGN THE DEED OF DONATION EXECUTED BY NARCISSA HOMES REPRESENTED BY RENEE N. ENRIQUEZ, AS DONOR IN FAVOR OF THE CITY GOVERNMENT OF ORMOC REPRESENTED BY THE HONORABLE ERIC C. CODILLA, CITY MAYOR AS DONEE OF PARCELS OF LAND CONTAINING AN AREA OF SIX THOUSAND ONE (6,001) SQUARE METERS.

WHEREAS, this Sanggunian is in receipt of a letter dated August 9, 2007 from the Honorable City Mayor requesting for the passage of a resolution authorizing his honor to accept and sign the Deed of Donation executed by Narcissa Homes, represented by Mrs. Renee N.
