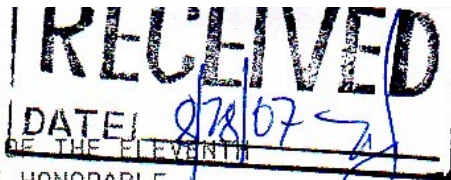

RESOLUTION NO. 2007-051

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE SECRETARY OF THE DEPARTMENT OF ENERGY TO CONDUCT THE TECHNICAL ASSESSMENT OF THE ENERGY RESOURCE OF MAHANAGDONG "A" & "B" GEOTHERMAL POWER PLANTS LOCATED AT BRGY. TONGONAN, ORMOC CITY, PURSUANT TO DEPARTMENT OF ENERGY (DOE) CIRCULAR NO. 98-01, SECTION 2.3 THEREOF.

WHEREAS, PNOC-EDC is operating the MAHANAGDONG "A" & "B" GEOTHERMAL POWER PLANTS located at Brgy. Tongonan, Ormoc City;

WHEREAS, the natural resources of MAHANAGDONG "A" POWER PLANT is allegedly located in two barangays, namely Brgy. Lake Danao and Brgy. Tongonan, both of Ormoc City;

WHEREAS, the royalty received pertaining MAHANAGDONG "A" & "B" GEOTHERMAL POWER PLANTS, insofar as the barangay share is concerned, is now deposited in local banks in the name of THE CITY TREASURER OF ORMOC;

WHEREAS, in order that the said royalty can be utilized by Brgys. Lake Danao and Tongonan, in the absence of the technical assessment of the energy resources they have decided to enter and sign a MEMORANDUM OF AGREEMENT relative to the sharing of their accumulated royalty, subject to adjustment when their respective share of the royalty will be determined with finality by the Department of Energy which is to conduct the requisite technical assessment;

WHEREAS, the aforementioned MEMORANDUM OF AGREEMENT was approved by this Sanggunian per Resolution No. 2005-192, a copy of which was furnished the Department of Energy;

WHEREAS, to settle once and for all the definite share of the royalty between Brgy. Tongonan and Brgy. Lake Danao, the Department of Energy is most respectfully requested to conduct the technical assessment of the energy resource of MAHANAGDONG "A" & "B" GEOTHERMAL POWER PLANTS soonest;

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Energy, severally seconded by City Councilors Jose C. Alfaro, Jr., Sotero M. Pepito and Domosthenes F. Tugonon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution EARNESTLY REQUESTING THE HONORABLE SECRETARY OF THE DEPARTMENT OF ENERGY TO CONDUCT THE TECHNICAL ASSESSMENT OF THE ENERGY RESOURCE OF MAHANAGDONG "A" & "B" GEOTHERMAL POWER PLANTS LOCATED AT BRGY. TONGONAN, ORMOC CITY, PURSUANT TO DEPARTMENT OF ENERGY (DOE) CIRCULAR NO. 98-01, SECTION 2.3 THEREOF;
