A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF ENERGY (DOE) REPRESENTED BY ITS UNDERSECRETARY, HON. MELINDA L. OCAMPO AND THE NATIONAL POWER CORPORATION (NPC) REPRESENTED BY ITS PRESIDENT, ATTY. CYRIL C. DEL CALLAR.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated March 6, 2007 from the Office of the City Mayor requesting for authority to sign the Memorandum of Agreement (MOA) for and in behalf of the City Government of Ormoc, with the Department of Energy represented by Undersecretary Melinda L. Ocampo and the National Power Corporation represented by its President, Atty. Cyril C. Del Callar;

WHEREAS, the said Memorandum of Agreement (MOA) pertains to the installation of Street Lighting Facilities in the Thirteen (13) barangays in Ormoc City as approved by this Sanggunian through SP Resolution No. 2006-220 dated October 12, 2006 to be funded from out of the ER 1-94 benefits accrued from the commercial operations of Leyte - Cebu and Leyte - Luzon Interconnection Project (Power Generated from Upper Mahiao, Malitbog and Mahanagdong A & B Geothermal Power Plants);

WHEREAS, the Memorandum of Agreement further cited that the Department of Energy (DOE), through Notice to Proceed (NTP) No. DLF2006-156, has appropriated the estimated amount of ₱10,654,000.00 for the implementation of the herein referred project;
