SAN PABLO, THIS CITY;

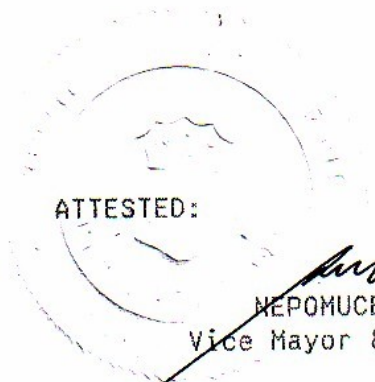

Chairman/Treasurer of the barangay concerned, -all in Ormoc City;


