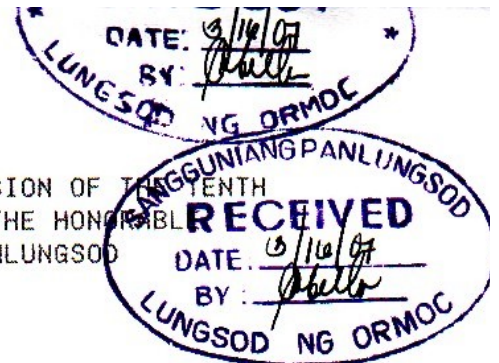

A RESOLUTION APPROVING ORDINANCE NO. 2007-001 OF THE
BARANGAY COUNCIL OF BARANGAY DON CARLOS RIVILLA, SR.,
THIS CITY, ENTITLED: "AN ORDINANCE PROHIBITING OWNERS
OF DOMESTIC ANIMALS, SUCH AS PIGS, CATTLE, GOATS, DOGS,
HORSES, AND FOWLS AS TURKEYS, GEESE, AND SIMILAR
ANIMALS AND FOWLS, FROM CAUSING THEM TO GO ASTRAY,
PROVIDING PENALTIES IN VIOLATION THEREOF".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
2007-001 of the Barangay Council of Barangay Don Carlos Rivilla, Sr.,
entitled: "AN ORDINANCE PROHIBITING OWNERS OF DOMESTIC ANIMALS, SUCH AS
PIGS, CATTLE, GOATS, DOGS, HORSES, AND FOWLS AS TURKEYS, GEESE, AND
SIMILAR ANIMALS AND FOWLS, FROM CAUSING THEM TO GO ASTRAY, PROVIDING
PENALTIES IN VIOLATION THEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City) is, by law, granted the Power to
review as to whether said ordinance is consistent with law and city x x


