A RECOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS AND THE ORMOC CITY LGU/ ORMOC WATERWORKS DIVISION.

WHEREAS, this Sanggunian is in receipt of an indorsement dated September 8, 2007 from the Hon. City Mayor Eric C. Codilla relative to the Memorandum of Agreement by and between the DPWH and the Ormoc City LGU/ Ormoc Waterworks Division (OWD) in relation to the manner of resorting to the outting/ breaking of concrete/ asphalt pavement of the National road and in the restoration thereof;

WHEREAS, the said Memorandum of Agreement mentions that the Ormoc City LGU/ Ormoc Waterworks Division (OWD), in the pursuit of its functions of providing water service to the consumer-applicants, has undertaken several cuttings of roads, pavements and asphalt overlays in different locations within the City of Ormoc;

WHEREAS, the DPWH-4th LED, being in charge in the construction and maintenance of roads and highways, stresses that proper coordination with their office shall be made by the Ormoc City LGU/ Ormoc Waterworks Division (OWD) prior to the conduct of the above activities in order to ensure that the affected roads or pavements, especially that which have asphalt overlay will be properly restored;

WHEREAS, both parties, having a common goal of providing quality service to the general public, have agreed to enter into an agreement for the purpose of delineating responsibilities in the implementation of their respective functions which are geared towards the benefit of the people;
