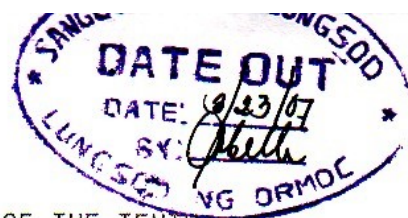
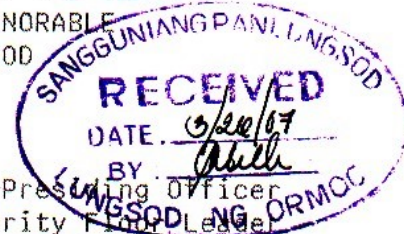

RESOLUTION NO. 2007-064

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO NEGOTIATE AND PURCHASE A LOT OWNED BY MR. LORETO CHU CONTAINING AN AREA OF 5,780 SQ. METERS SITUATED AT BARANGAY IPIL, ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated March 19, 2007 from the Office of the City Mayor urgently requesting for the passage of a resolution authorizing the Honorable City Mayor to negotiate and purchase a lot owned by Mr. Loreto Chu particularly described as Lot No. 1860-B covered by TCT No. 48220 containing an area of 5,780 sq. meters situated at Brgy. Ipil, this city, to be used as a site for the construction of a water reservoir and multi-purpose building for the City Health Office;

WHEREAS, the personnel from the City Planning and Development Office has made an Evaluation of Property and finds that the subject lot is suitable to be used as a site for the above-mentioned development projects of the city;

WHEREAS, at the price at which the property is being offered, the selling price of more or less P865.05 only per square meters, which is very reasonable;

WHEREAS, this august Body believes that said request is reasonable hence, the same must be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriation, duly seconded by City Councilor Sotero M. Pepito; be it
