PRESENTED, to this august Body for concurrence, through 1st Indorsement dated March 19, 2007 from the Honorable City Mayor Eric C. Codilla is the appointment of Dr. Nelia D. Navales as City Government Department Read I (City Health Officer II), this city, effective March 16, 2007;

WHEREAS, Art 119, Par. (a) - Rules and Regulations Implementing the ocal Government Code provides:

"(a) Unless otherwise provided in this Rule, heads of offices and departments in the LGU's shall be appointed by the Local Chief Executive concerned with the concurrence of a majority of all the members of the sanggunian, subject to civil service laws, rules and regulations." (underscoring supplied)
