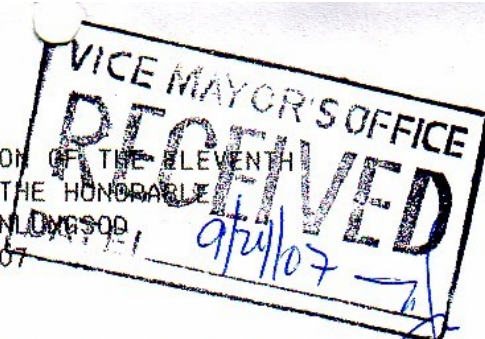
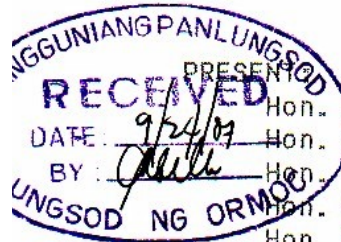
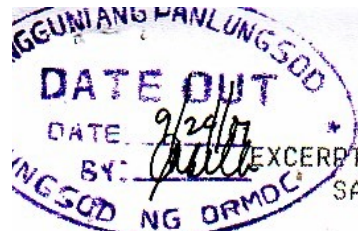

RESOLUTION NO. 2007-068

A RESOLUTION FURTHER AMENDING SECTION I, RULE V OF THE  
RULES AND PROCEDURES OF THE SANGGUNIANG PANLUNGSOD OF  
ORMOC CITY.

WHEREAS, Section I, Rule V of the interim Rules and Procedures of the Sangguniang Panlungsod of Ormoc City has earlier been amended as per Ordinance No. 121, Series of 2005, entitled: "AN ORDINANCE AMENDING SECTION I RULE V OF THE RULES AND PROCEDURES OF THE SANGGUNIANG PANLUNGSOD OF ORMOC CITY";

WHEREAS, said Ordinance No. 121 provides that the time of the Pre-Session Caucus of the Sangguniang Panlungsod be changed from 8:30 in the morning of every Monday to 9:30 in the morning of same day;

WHEREAS, said amendment has already been incorporated in the present Interim Rules and Procedures of the august Body which was adopted in toto by the 11th Sangguniang Panlungsod ng Ormoc;

WHEREAS, upon proper deliberation and consideration, this august Body believes that the same be revised and amended further to suit the present needs and activities of the Sangguniang Panlungsod Members by changing the time of the Pre-Session Caucus from 9:30 in the morning of every Monday as provided for in Ordinance No. 121, Series of 2005 to 8:30 in the morning of every Monday;

WHEREAS, in this effect, Section I of Rule V of the Rules and Procedures of the Sangguniang Panlungsod of Ormoc City will now be read as follows:

RULE V- SESSION, QUORUM AND ATTIRE

Section I. PRE-SESSION CAUCUS- Shall be held every Monday at 8:30 in the morning at the Sangguniang Panlungsod Conference Room for the purpose of determining and discussing the agenda for the regular session provided however, that if a Monday happens to be a holiday the Pre-Session Caucus shall be held on the next succeeding business day at the same time and place as may be agreed upon by the Kagawad.



WHEREFORE, FOREGOING PREMISE CONSIDERED, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Internal Rules duly seconded by Claudio P. Larrazabal; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution "FURTHER AMENDING SECTION I, RULE V OF THE RULES AND PROCEDURES OF THE SANGGUNANG PANLUNGSOD OF ORMOC CITY"; to now read as follows:

RULE V- SESSION, QUORUM AND ATTIRE
