A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO RURCHASE THE LOTS AFFECTED BY THE REMABILITATION/IMPROVEMENT/EXPANSION OF THE ORMOC CITY WATERWORKS SYSTEM.
