A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ACCEPT AND SIGN THE DEED OF DONATION EXECUTED BY ATTY. IÑAKI P. LARRAZABAL, JR. IN FAVOR OF THE CITY GOVERNMENT OF ORMOC FOR A PARCEL OF LAND WITH AN AREA OF ONE THOUSAND (1000) SQUARE METERS SITUATED AT BRGY. DONGHOL, ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated March 19, 2007 from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to accept and sign the Deed of Donation executed by Atty. Iñaki P. Larrazabal, Jr. in favor of the City Government for a parcel of land with an area of One Thousand (1000) sq.m. situated at Brgy. Donghol, Ormoc City;

WHEREAS as cited in the said Deed of Donation, the Donor (Atty. Iñaki P. Larrazabal) freely and voluntarily gives, transfers and conveys by way of donation unto donee (City Government of Ormoc) a portion of lot 2924 containing One Thousand (1000) sq.m. for the sole purpose of having the City Government construct a Water Reservoir;

WHEREAS, this august Body believes that said donation made by the donor is of great help to the City of Ormoc having been made with the object of not defrauding their creditors and having reserved to themselves property sufficient to answer for their debts contracted prior to said donation;
