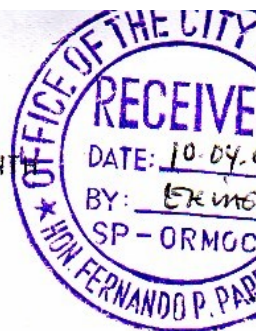

A RESOLUTION APPROVING THE CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 6, SERIES OF 2007, ENTITLED: "A RESOLUTION APPROVING THE RE-CREATION OF THE LOCAL ZONING BOARD OF ADJUSTMENT AND APPEALS (LZBAA) AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME".

WHEREAS, this august Body is in receipt of an Indorsement dated September 14, 2007 from the Office of the City Mayor Indorsing City Development Council (CDC) Resolution No. 6, Series of 2007, entitled: "A RESOLUTION APPROVING THE RE-CREATION OF THE LOCAL ZONING BOARD OF ADJUSTMENT AND APPEALS (LZBAA) AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME";

WHEREAS, it can be recalled that the Tenth Sangguniang Panlungsod ng Ormoc passed Sangguniang Panglungsod Resolution NO. 2007-050 dated March 8, 2007 approving the City Development Council Resolution No. 1, Series of 2007 which created the Local Zoning Board of Adjustment and Appeals (LZBAA) in this city;

WHEREAS, said City Development Council Resolution No. 6 cited that in as much as a new set of City Officials have been elected which now comprises the Eleventh Sangguniang Panlungsod ng Ormoc, there is a need to re-create the Local Zoning Board of Adjustment and Appeals (LZBAA) in order to consistently carry out the functions and responsibilities of the Board as provided for in Sangguniang Panlungsod Resolution No. 2007-050;

WHEREAS, this august Body believes that the re-creation of the Local Zoning Board of Adjustment and Appeals (LZBAA) is very important to the continuous development of the city:


