A RESOLUTION REQUESTING THE DEPARTMENT OF ENERGY (DOE) TO ADVISE NPC/TRANSCO AND OTHER CONCERNED POWER COMPANIES UTILIZE AND OR MAXIMIZE THE UTILIZATION GEOTNERMAL AND OR LOAD CURTAILMENT AND OR HYDROPOWER SOURCE OF ENERGY DURING PERIOD CONSIDERING THAT UTILIZATION WILL GREATLY HELP IN PREVENTING OR AT LEAST MITIGATING CLIMATE CHANGE RESULTING TO GLOBAL WARMING.

it is a fact that during times of low demand for electricity WHEREAS, power companies conduct what is referred to as load curtailment;

WHEREAS, during these load curtailment/ reduction activities the energy sources utilized are from coal-fired plant and/ or diesel fuel plants, (all from fossil fuel sources which are non-renewable);

WHEREAS, both sources emit significant amount of carbon dioxide and sulfur dioxides which are identified as greenhouse gases and are Persistent Ozone Polluting Substances (POPS), aside from being harmful to health;

WHEREAS, geothermal energy and hydro energy cannot be stored and do not drain our dollar reserve while oil and coal may be stored if not utilized thus saving us our precious dollars;

WHEREAS, this move therefore has advantageous effect not only for environment but also for our economy;

WHEREAS, this move by the Sangguniang rantungood pass saying "Think Globally, act Locally"; we are acting locally with the passage of this resolution and thus will contribute to the global effect reducing global warming;
