A RESOLUTION AMENDING SANGGUNIANG PANLUNGSOD RESOLUTION NO. 2007-028 DATED AUGUST 2, 2007, ENTITLED: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE RENEWAL CONTRACT FOR CONSULTANCY OF DR. SAMUEL S. GO, AS CONSULTANT FOR AGRICULTURE, THIS CITY, EFFECTIVE FEBRUARY 1, 2007 TO DECEMBER 31, 2007" BY MODIFYING THE EFFECTIVITY DATE THEREOF FROM FEBRUARY 1, 2007 TO MARCH 1, 2007.

WHEREAS, this Sanggunian is in receipt of an indorsement dated September 21, 2007 from the Honorable City Mayor Eric C. Codilla, urgently requesting for the amendment of SP Resolution No. 2007-028, entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE RENEWAL CONTRACT FOR CONSULTANCY OF DR. SAMUEL S. GO, AS CONSULTANT FOR AGRICULTURE, THIS CITY, EFFECTIVE FEBRUARY 1, 2007 TO DECEMBER 31, 2007;

WHEREAS, the Honorable City Mayor had clarified that the previous Contract for Consultancy of Dr. Samuel S. Go has expired on February, 2007, hence, the effectivity date of the Renewal Contract of Consultancy should be March 1, 2007 instead of February 1, 2007 as provided for in SP Resolution No. 2007-028;

WHEREAS, in order to properly enforce the Renewal Contract for Consultancy of Dr. Samuel S. Go, there is a need to amend the existing SP Resolution No. 2007-028 by modifying the effectivity date of the renewal contract from February 1, 2007 to March 1, 2007;

WHEREAS, in consideration thereof, this august Body believes that the request of the Honorable City Mayor is just and reasonable hence, the same should be given the necessary course of action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture, duly seconded by City Councilor Rafael C. Omega, Jr.; be it


