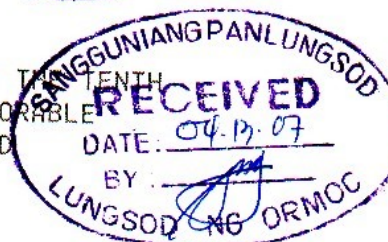

OUR CHILDREN";

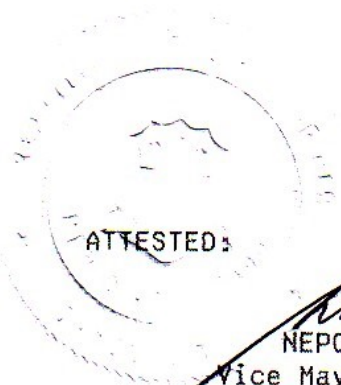
