

A RESOLUTION RETURNING TO THE SANGGUNIANG PAMBARANGAY OF IPIL, ORMOC CITY, THEIR ORDINANCE NO. 2007-002, ENTITLED: "AN ORDINANCE IMPOSING A TAX ON STORES, OR RETAILERS WITH A FIXED BUSINESS ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOORS SIGNS, SIGNBOARDS, AND BILLBOARDS, AND FEES ON CLEARANCES AND CERTIFICATIONS ISSUED BY THE BARANGAY TO ANY PERSON". 




