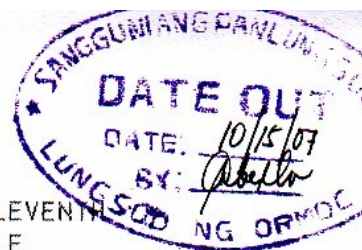

RESOLUTION NO. 2007-084

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF AGRICULTURE- REGIONAL FIELD UNIT NO. 8 FOR THE PROVISION OF ONE (1) UNIT MECHANICAL DRYER AND OTHER FACILITIES FOR THE GININTUANG MASAGANANG ANI (GMA) CORN PROGRAM.

WHEREAS, this Sangguniang is in receipt of a letter dated September 26, 2007 from the Honorable City Mayor Eric C. Codilla requesting for the passage of a resolution authorizing His Honor to enter and sign a Memorandum of Agreement in behalf of the City Government of Ormoc with the Department of Agriculture- Region 8 for the provision of One (1) Unit Mechanical Dryer and other facilities for the Ginintuang Masaganang Ani (GMA) Corn Program;

WHEREAS, the implementation of the GMA Corn Program in the City of Ormoc is geared towards poverty alleviation of the agricultural sectors and achieving food security as envisioned under RA 8435, otherwise known as Agriculture and Fisheries Act of 1995 (AFMA);

WHEREAS, the Memorandum of Agreement mentions that the City of Ormoc will avail of the aforementioned facilities through counterparting scheme with the Department of Agriculture to be used in the development and transformation of corn farm cluster production into modern agribusiness system through mechanized production;

WHEREAS, this august Body finds the terms and conditions of the said Memorandum of Agreement as just reasonable, hence, the requested authority by the Honorable City Mayor to sign the same should be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture, jointly seconded by City Councilors Ruben R. Capahi and Demosthenes F. Tugonon; be it




