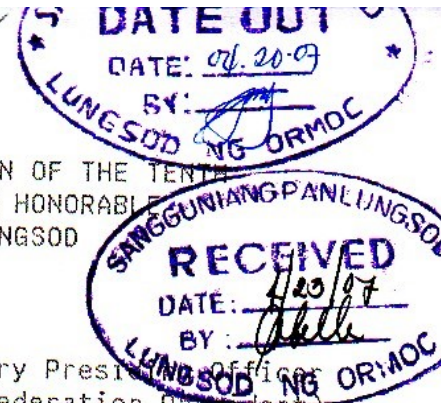

A RESOLUTION RETURNING TO THE SANGGUNIANG PAMBARANGAY OF IPIL, THIS CITY, THEIR BARANGAY ORDINANCE NO. 2007-001, ENTITLED: "AN ORDINANCE AMENDING SOME PROVISIONS OF RESOLUTION ORDINANCE NO. 02-89, EMBODYING THE "TOLL COLLECTION ORDINANCE NO. 89-2, BY WAY OF CATEGORIZING THE LEVY AND ENCREASING (SIC) THE AMOUNTS THEREIN" FOR THE REASON THAT THE BASIS FOR THE IMPOSITION OF THE TAX IS AMBIGUOUS AND SHOULD THEREFORE BE CORRECTED.

WHEREAS, this sanggunian is in receipt of Barangay Ordinance No. 2007-001 of the Barangay Council of Barangay Ipil, entitled: "AN ORDINANCE AMENDING SOME PROVISIONS OF RESOLUTION ORDINANCE NO. 02-89, EMBODYING THE "TOLL COLLECTION ORDINANCE NO. 89-2, BY WAY OF CATEGORIZING THE LEVY AND ENCREASING (SIC) THE AMOUNTS THEREIN";

WHEREAS, aforesaid Ordinance No. 2007-001, was submitted to this Sanggunian for review as mandated in Section 57, of the Local Government Code of 1991;

WHEREAS, it is the observation of this august Body that the said ordinance does not conform to the pertinent provisions of the Local Government Code, for the reason that the basis for the imposition of the tax is ambiguous and should therefore be corrected;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, duly seconded by City Councilor Sotero M. Pepito; be it
