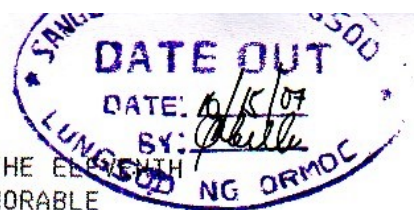

SUPPLEMENTAL BUDGET NO. 02




