WHEREAS, according to the Memorandum Report of the City Electrification Subsidy Council, the City Treasurer of Ormoc is charged in the proper implementation of the program;

WHEREAS, aforementioned Memorandum Report provides that the subsidy will given in December of every year;

WHEREAS, per certification dated October 5, 2007 of the City Treasurer of Ormoc, the total amount of ₱14,571,487.67 is available for distribution to electric consumers of Ormoc City for Calendar Year 2007, a photocopy of which is hereto attached for ready reference;

WHEREAS, in order that the distribution of the subsidy will be done on time, and without any hitch, the City Treasurer of Ormoc should now make the necessary preparation, especially the securing of a certified list of electric consumers of Ormoc City as of October 31st, 2007, from LEYECO V;




